



## Oral health is an essential part of overall health at every age, helping prevent and manage chronic diseases.

Delta Dental's 2024 community investments expand mobile dentistry for older adults and veterans, support rural dental clinics, and strengthen oral health education for children. Together, these efforts are creating healthier communities and closing gaps in care.





Delta Dental partners with clinics, community centers, and long-term care facilities to improve oral health and well-being for older adults.

Older adults face the highest risk for poor oral health; nearly 70% have gum disease, and nearly 1 in 5 live with untreated cavities. Yet, 80% of older adults don't visit the dentist as often as recommended. Visiting the dentist matters: Poor oral health is linked to chronic conditions like diabetes, cardiovascular disease, and Alzheimer's.

Delta Dental is dedicated to ensuring that older adults have access to high-quality oral health care. Our companies and foundations work closely with local partners to provide direct oral care and develop programs to support the oral and overall health of older adults.

## Providing on-site dental care to older adults

Delta Dental of Rhode Island and CareLink Mobile Dentistry provided on-site dental care to older adults and adults with disabilities at long-term care facilities, assisted living, senior centers, community centers, recovery programs, and homeless transition programs.

## Improving access to oral care for older adults

**Delta Dental Community Care Foundation** invested \$15 million in programs focused on improving access to oral care for older adults.

**Delta Dental of South Dakota Foundation** covered the cost of oral health care for older adults and individuals with disabilities through the Donated Dental Services Program, providing care to over 70 patients in 2024.

**Delta Dental of Iowa Foundation** supports the I-Smile Silver program, which connects older adults with dental, medical, and community resources.

## Training caregivers in older adults' oral healthcare

Hawaii Dental Service Foundation supported the Kupuna Smiles program, which addresses the oral health needs of older adults in long-term care facilities by offering hands-on oral health training for nurses. In 2024, over 400 nurses and caregivers were trained in long-term care facilities statewide.

**Delta Dental of Arizona Foundation** partnered with Banner Medical Centers to implement oral health protocols for older adults that identify barriers to dental care and promote the integration of medical and dental care.

**Delta Dental Institute** sponsored research from the University of Iowa College of Dentistry and Dental Clinics, finding caregivers that used the mobile app Dental.Aging. Tips were more confident in providing oral hygiene and care to older adults living with dementia.

Nearly <u>25 million Americans live in 'dental deserts</u>,' areas with too few dentists to meet demand. These shortages are especially common in rural communities, affecting <u>95% of rural counties</u>. The result: delayed treatment and worsening oral health <u>outcomes</u>.

In 2024, Delta Dental delivered more than 1.2 million free or low-cost dental screenings and exams through mobile clinics, school sealant programs, and grants, helping close gaps in care by meeting people where they live.



## Expanding rural access to dentists

Delta Dental of North Carolina helped fund the expansion of the High Country Community Health Dental Clinic, a federally qualified health center that improves access to oral health services for individuals in rural North Carolina. Delta Dental of North Carolina also funded the ECU School of Dental Medicine's Smiles for Veterans program, which offered free dental treatment to uninsured veterans in rural North Carolina.

**Delta Dental Community Care Foundation** provided funding to Cabin Creek Health Systems, a small network of community health centers in West Virginia, to offset the cost of dental care for low income and elderly patients.

## Providing mobile care for rural communities

**Delta Dental of Oregon and Alaska** invested in Tooth Taxi, a mobile dental clinic that brings free care to underserved kids in vulnerable communities.

## Offering culturally tailored dental access

Supported by the **Delta Dental of Arkansas Foundation**, El Centro Hispano expanded access to dental care for Spanish-speaking communities in rural Arkansas. The organization reached up to 4,500 individuals with culturally tailored resources.

As a small network of community health centers in southern West Virginia Cabin Creek Health Systems works diligently to increase access to affordable oral health care for our rural patient population. Our partnership with the Delta Dental Community Care Foundation (DDCCF) provides funding support to help offset providing services to our lowincome and elderly patients below the cost of our supplies and materials. Without the generosity of DDCCF we would not be able to continue to offer these much-needed dental services.

## Delta Dental supports veterans' oral health through free and reduced-cost care delivered in partnership with nonprofits and health centers.

Of the nearly 9 million veterans who are eligible for medical care through the U.S. Department of Veterans Affairs, just 6% receive dental coverage through the VA. The lack of infrastructure and coverage often results in a poorer quality of life and disparate oral and overall health outcomes for veterans.

In 2024, Delta Dental companies supported 35 initiatives that served veterans. Through partnerships with state agencies, community health centers, and nonprofits, we have funded programs that provide free or low-cost dental services to veterans, including those who are low-income, experiencing homelessness, or medically vulnerable.











## Serving veterans with care

**Delta Dental of New Jersey and Connecticut** co-hosted Smiles for Our Heroes, a one-day event of free dental care for 75 veterans. Since its inception, Smiles for Our Heroes has served nearly 800 veterans.

**Delta Dental of Nebraska** sponsored the Veterans Mission of Mercy, during which volunteers provided no-cost dental care to 396 veterans and spouses, delivering over \$650,000 in care.

## Delivering free care to medically fragile veterans

Delta Dental companies in Arizona, Colorado, Kentucky, Maine, New Hampshire, New Jersey, Oklahoma, Vermont, Virginia, Washington, and Wisconsin contributed to Dental Lifeline Network, helping nearly 700 veterans access oral care valued at over \$2.3 million.

Delta Dental of Minnesota Foundation funded the Donated Dental Services program to provide no-cost, comprehensive dentistry in the private offices of dentists in Minnesota to veterans.

## Partnering to serve veterans

**Delta Dental Foundation** (an affiliate of Delta Dental of Michigan, Indiana, and Ohio) partnered with the University of Michigan Victors for Veterans program, where students and faculty create comprehensive treatment plans for disabled or uninsured veterans and provide dental care free of charge.

**Delta Dental of Tennessee** supported Operation Stand Down, which provides housing, financial assistance, and mental and physical health support for veterans in crisis.


# We're teaching kids lifelong oral health habits through school-based programs with hands-on learning and preventive care.

Preventive dental care and good habits at home are essential to good overall health, especially for children. Due to dental caries and other oral health challenges, children, on average, miss more than 51 million hours of school per year. Addressing oral health through education is not merely a dental concern; it is critical in ensuring a child's development and future success.

Delta Dental invested \$8 million in oral health education programs in 2024, impacting 7 million lives. Our focus: closing a critical gap in oral health education, a key driver of poor health outcomes in children. We have also invested \$3.5 million in school sealant programs, providing preventive care to more than 165,000 children.

With almost 50% of our families living below the poverty level, you can imagine that dental care is oftentimes not the first priority for our families. Thank you for helping to fill this gap. ## Teaching age-appropriate oral healthcare

The Land of Smiles program, offered by **Delta Dental of Connecticut, Idaho, Illinois, Missouri, New Jersey, and South Carolina,** is a fun and age-appropriate initiative designed to teach children in kindergarten through third grade about the importance of good oral health. Through both in-person and virtual performances, the program has reached over 2.2 million students across all three states, highlighting the value of a healthy smile and proper dental care.

Delta Dental of Oklahoma Foundation's Delta Dental Cavity
Prevention Clinic is a vital preventive treatment program offered
free to 2nd and 6th grade students at Oklahoma schools. Dental
professionals, utilizing portable equipment, deliver dental
assessments and sealants in the convenience and safety of the
child's school. Students are also referred to local dentists and
encouraged to establish a dental home if they don't have one.

**Delta Dental of Massachusetts** funded community and school-based screenings and direct care.

**Delta Dental of Puerto Rico** organized school-based talks to educate students about the importance of oral health and partnered with organizations to distribute oral health kits.





## Expanding care for kids and new mothers

The Wyoming Delta Dental Foundation partnered with the Wyoming Dental Association's local dental districts to organize Give Kids a Smile day in Cheyenne & Rock Springs, which provided free dental care to over 100 uninsured children. The Foundation also partnered with the Wyoming Dental Association to support the Healthy Little Smiles program that provides new moms with oral health kits that help them learn how to take care of their baby's teeth and gums.

**Delta Dental of Kansas** provides Smile Kits containing a toothbrush, toothpaste, and floss to Kansas-based programs and projects that include an oral health education or outreach component.

## Bringing the value of oral health prevention to schools

**Delta Dental of Idaho's** Grins on the Go is a free cavity prevention clinic for low-income elementary and middle schools statewide. In 2024, the program reached 135 schools and 24,000 children.

Delta Dental of Virginia Foundation, in partnership with Virginia Health Catalyst, the Virginia Department of Health, and the Department of Education, funded a learning collaborative to strengthen existing or build new school-based oral health programs.



In 2024, Delta Dental companies and their foundations invested more than \$18 million to help support the next generation of the oral health workforce.

Building a strong oral health workforce is essential to expanding access to care and improving health outcomes.

Delta Dental is proud to have awarded \$980,000 in 2024 to six outstanding organizations to support the future of the oral health workforce. The awardees — American Dental Education Association, Diversity in Dentistry Mentorships, Inc., NAF, National Dental Association, Planet Smilez, Inc., and the Society of American Indian Dentists — are engaging and inspiring school-aged children to explore purpose-driven careers in oral health. These programs pave the way for a new generation of oral health professionals by providing students with mentorship, educational resources, and immersive experiences.

Delta Dental of Colorado celebrated the opening of the newly renovated Delta Dental Oral Health Career Center at Pikes Peak State College. The investment helped create a state-of-the-art facility that features two clinics with a total of 20 chairs, a high-fidelity simulation lab, and advanced dental technology, including intra-oral and 3D imaging, as well as CAD/CAM crown design. Additionally, this investment will help the school to accredit a dental hygiene program.

Northeast Delta Dental committed \$2 million to help establish an Oral Health Education Center in Vermont by 2027. The University of Detroit Mercy School of Dentistry (UDM), in collaboration with the Vermont State Dental Society, will bring UDM students to Vermont to complete their final years of training, addressing the state's dental provider shortage.



Delta Dental of Kentucky announced a multi-year partnership with the University of Pikeville's Tanner College of Dental Medicine, aimed at expanding opportunities for students to pursue dental careers in Eastern Kentucky. As part of the collaboration, Delta Dental is providing \$2.35 million in funding to support college furnishings, equipment purchases, and student scholarships.

Delta Dental of Wisconsin Foundation committed \$2 million to support the Technical College Dental Workforce Program. This funding aims to expand access to dental care, strengthen the dental workforce, and improve oral health for underserved and vulnerable communities.

**Delta Dental of New Mexico** partnered with **Doña Ana Community College** dental hygiene students & faculty members to provide free oral health services at clinics.

Delta Dental of Washington/Arcora
Foundation supports the Dental Career
Discovery Program, a hands-on program
giving young people, especially those from
historically underrepresented groups, the
chance to experience the dental field. In 2024,
the program reached more than 1,200 youth
across Washington.

#### American Heart Association

Delta Dental supported the American Heart Association's Healthy Smiles,

Healthy Hearts™ program, a national initiative that will expand care settings that
deliver equitable, high-quality, and integrated care. With a total commitment of
\$4 million in 2024, led by Delta Dental of California, this initiative will engage
oral health clinicians to create and implement a new standard of care for heart
health screening at the dentist's office. Additionally, the initiative will also educate
health care professionals and patients on the link between heart health and oral
health, emphasizing the importance
of a patient's integrated care team in
improving total health and well-being.

**Delta Dental of New Mexico** worked with the **American Heart Association** to support the "Life is Why" program, encouraging New Mexicans to exercise and eat heart-healthy food. Additionally, they participated in prominent events across the state to promote heart-healthy behaviors.

**Delta Dental of Kentucky** collaborated with the **American Heart Association** to assist patients with hypertension control by providing the community with increased access to blood pressure monitoring through the installation of a tabletop machine in clinic waiting rooms.

#### Disaster Relief & Rapid Response

In 2024, Delta Dental companies and their foundations partnered with the American Red Cross and other local organizations by donating over \$1.3 million to disaster relief efforts across the U.S., including urgent support and relief efforts for Hurricanes Helene and Milton, in addition to critical healthcare supplies. These investments help local communities stabilize, rebuild, and access essential resources when they need them most.

In collaboration with the **American Red Cross**, Delta Dental sponsored blood drives that collected 188 units of blood, enough to save over 560 lives.



Our collaboration with the American Heart Association marks a pivotal step towards strengthening access to quality, integrated care and emphasizes the role of dental visits as part of a holistic health check which can offer early detection of cardiovascular disease and other conditions.
